### INVESTMENT OBJECTIVE

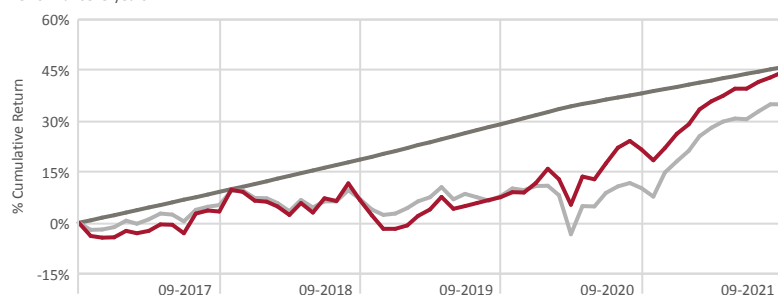
The 36ONE BCI Flexible Opportunity Fund is a flexible managed portfolio that aims to provide investors with high long-term capital growth.

The portfolio may from time to time invest in listed and unlisted financial instruments. The manager may include the following unlisted financial instruments: forward currency swaps, interest rate and exchange rate swap transactions for efficient portfolio management purposes.

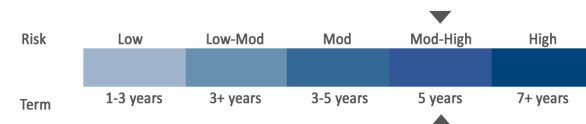
