The Absa Sanlam Multi Managed Core Growth Fund provides investors with access to investments aimed at capital growth over the long term.

Fund Strategy

In order to achieve the objective, the will managed in compliance with the prudential investment guidelines for retirement funds in South Africa to the extent the allowed for by the Act.

The fund will invest in various local and foreign asset classes. The fund may from time to time invest in listed and unlisted financial instruments, in accordance with the provisions of the Act as amended from time to time. The portfolio's equity exposure will be limited to a minimum of 60% and maximum 75% of the portfolio net asset value. The fund is managed according to the guidelines as set out in regulation 28 of the pension funds act and is suitable for retirement funds Investments.

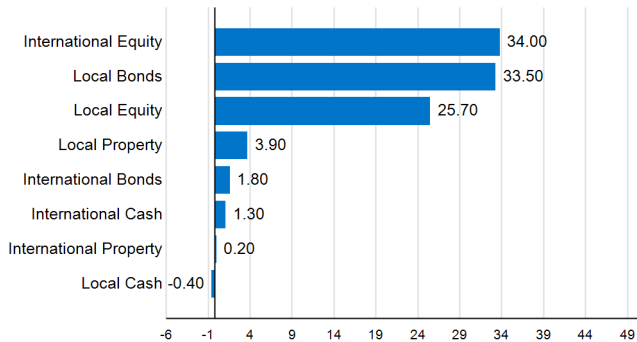
