The Absa Sanlam Multi Managed Core Preserver Fund provides inventors with access to investments aimed at capital preservation over the long term, with minimal probability of capital loss over the medium term.

Fund Strategy

In order to achieve the objective, the investments to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing securities, bonds, debentures, corporate debt, equity securities, property securities, preference shares, convertible equities, convertible debentures and nonequity securities. The portfolio equity exposure will be limited to a minimum of 40% and maximum 60% of the portfolio net asset value. The fund may from time to time invest in listed and unlisted instruments, in accordance with the provisions of the Act as amended from time to time, in order to active the portfolio objective. The Absa Sanlam Multi Managed Core Accumulation Fund will be a Multi Managed portfolio. The fund is managed according to the guidelines as set out in regulation 28 of the pension funds act and is suitable for retirement funds Investments.


