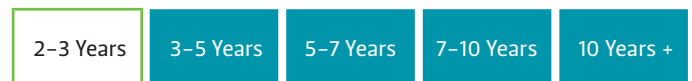

Minimum investment term



















Strategy objective

This is a multi-managed asset allocation fund that aims to produce returns of inflation plus 2-3%, net of fees, over a rolling 2 to 3-year time horizon.

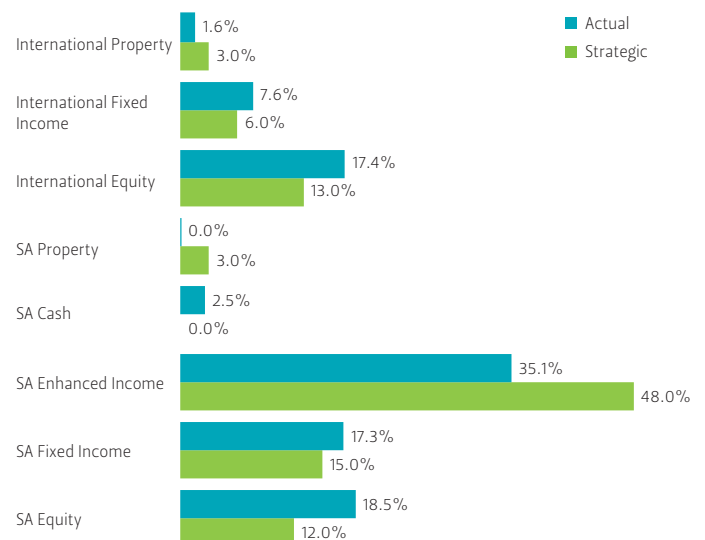
Investment universe

The strategy mainly invests in domestic and international collective investment scheme funds and exchange traded funds with exposure to domestic and international equities, fixed income, property and cash.

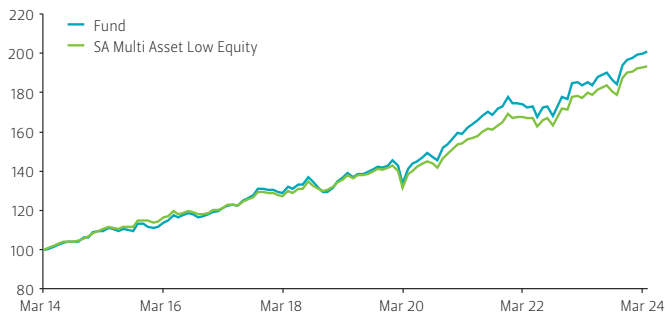

Asset allocation

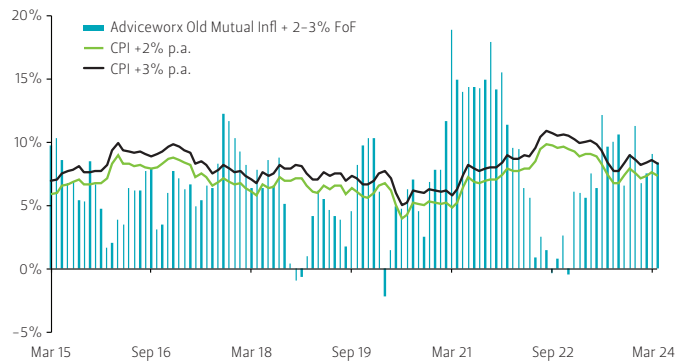


Cumulative investment performance

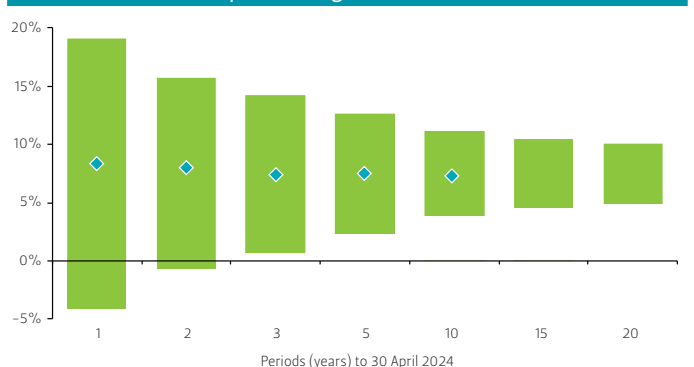

Fund Commentary

South African equities bucked the global trend in April, with the FTSE/JSE Capped SWIX retuning 3% in the month. This pushed the 2024 return into marginal positive territory while the one-year return of 2.4% lags cash and inflation by some distance.

The resources sector gained 7% in the month but is still down 8% from a year ago. Industrials had a positive month, but the one-year is only 1.5%. Financials gained 3% to narrow the year-to-date loss, but it remains the best performing of the three traditional economic sectors with an 11% return over 12 months.

South African bonds were positive in April, escaping the global sell-off. The JSE All Bond Index returned 1.4%. The one-year return of 6.8% lags cash (STeFi Composite) at 8.5%. Inflation-linked bonds returned 0.2% in April and 5.4% over 12 months.

Listed property was marginally negative in April, but the 12-month return of 13% on the FTSE/JSE All Property Index (ALPI) is still ahead of other local asset classes.

The rand remains rangebound against the US dollar. It ended the month slightly stronger at R18.83 per dollar, but this was still 3% weaker than a year ago.

Total expense ratio (TER) is a historical measure of the impact the deduction of management and operating costs have on a fund's value. The TIC includes:

- Other charges incurred by the underlying funds are deducted from their portfolios.
