

## **Risk Profile**

#### Aggressive

# **Glossary Terms**

# Annualised Returns

Annualised return is the weighted average compound growth rate over the period measured.

Asset allocation is the percentage holding in different asset classes (i.e. equities, bonds, property, etc.). It is used to determine the level of diversification in a portfolio.

#### Capital Volatility

Volatility is a measure of 'risk' and refers to the extent to which the price of an investment or capital value fluctuates over a certain period of time. Funds with high volatility usually offer the potential for higher returns over the longer term than low volatility funds

#### Cumulative Returns

Cumulative return is the total growth experienced over the period measured.

Derivatives are instruments generally used as an instrument to protect against risk (capital losses), but can also be used for speculative purposes. Examples are futures, options and swaps.

The income that is generated from an investment and given to investors through monthly, quarterly, biannual or annual distribution pay-outs.

## Diversification

This is a strategy designed to reduce risk within a portfolio by combining a variety of investments (or asset classes) such as equities, bonds, cash or property, which are unlikely to all move in the same direction at the same time. This is designed to reduce the risk (and protect against capital losses) within a portfolio. Diversification allows for more consistent performance under a wide range of economic conditions as it smoothes out the impact of negative market events. The positive performance of some investments or asset classes should neutralize the negative performance of others.

## **Financial Instruments**

Derivatives also known as financial instruments (such as a future, option, or warrants) whose value derives from and is dependent on the change in value of an underlying asset (such as a commodity, currency, or security) to protect against risk (capital losses).

## **Fund Objective**

The fund objective is the portfolio's core goal.

# Fund Strategy

The fund strategy is the way that the fund is managed to achieve the fund objective.

The Information Ratio measures the market risk-adjusted performance of an investment or portfolio. The greater a portfolio's Information Ratio, the better its risk-adjusted performance has been compared to the market in general.

# **Collective Investment Schemes**

Collective Investment Schemes (CIS) (also called unit trusts) are portfolios of assets such as equities, bonds, cash and listed property, in which investors can buyunits. They allow private investors to pool their money together into a single fund,thus spreading their risk across a range of investments, getting the benefit ofprofessional fund management, and reducing their costs.

LISP (Linked Investment Service Provider)

A Linked Investment Service Provider is a financial institution which packages, distributes and administers a broad range of unit trust investments.

Market Capitalization

Market capitalization is the total value of the issued shares of a publicly traded company; it is calculated by multiplying the share price by the number of shares in issue

# Maximum Drawdown

The maximum drawdown measures the highest peak to trough loss experienced by the fund.

When you buy a unit trust, your money is pooled with that of many other investors. The total value of the pool of invested money in a unit trust fund is split into equal portions called participatory interests or units. When you invest your money in a unit trust, you buy a portion of the participatory interests in the total unit trust portfolio. Participatory interests are therefore the number of units that you have in a particular unit trust portfolio.

# Sharpe Ratio

The Sharpe Ratio measures total risk-adjusted performance of an investment or portfolio. It measures the amount of risk associated with the returns generated by the portfolio and indicates whether a portfolio's returns are due to excessive risk or not. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

## Standard Deviation

Standard deviation (also called monthly volatility) is a measure of how much returns on an investment change from month to month. It is typically used by investors to gauge the volatility expected of an

# **Portfolio Manager Comment**

As at 30 June 2023

## International developments

US inflation has continued its downward trend, easing to 4% year on year in May, down from 4.9% in April. However, US Fed Chair, Jerome Powell, commented that the Fed would continue to hike interest rates even further in order to combat inflation. The continued uncertainty around the interest rate cycle and the potential for a US recession remained the key drivers of sentiment and global markets over the quarter.

#### South Africa

The SARB decided to increase the repo rate by a further 50 bps to 8.25% in May. The decision was in line with market expectations, although interest rates have risen significantly more than was anticipated a year ago. Given the hawkish tone of the Fed, there might be another, hopefully final, hike at the next Monetary Policy Meeting to be held on 20 July 2023. Headline consumer inflation slowed more than expected to 6.3% in May from 6.8% in April.

#### Position going forward and conclusion

The funds have been positioned overweight offshore assets and underweight SA government bonds going into the second quarter. As we enter the third quarter of the year we maintain these positions as a measure of risk management, despite both local equities and bonds trading well below intrinsic value. We remain positive of the likely performance of local assets going forward, but continue to apply caution as we expect that for the next 6 to 12 months uncertainty around global inflation remains elevated.
