

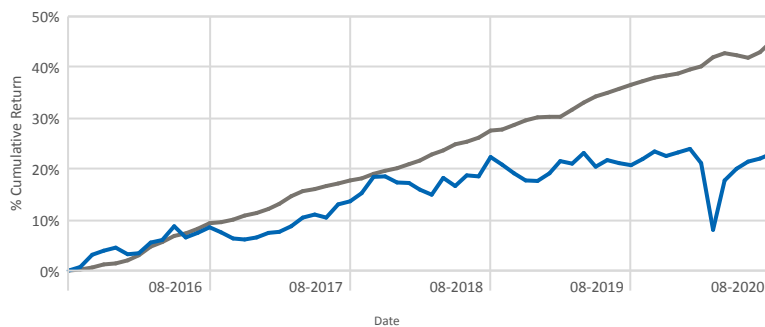
INVESTMENT OBJECTIVE

The API BCI Stable Fund of Funds is a cautious risk profile portfolio with the objective of targeting a high level of income and relatively stable capital growth by maintaining investment exposures across various asset classes.

INVESTMENT POLICY

To provide a limited level of capital protection, the portfolio's equity exposure may be as high as 40% of the portfolio's net asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes, which is consistent with the portfolio's primary objective, investing in equity securities, property securities, non-equity securities money market instruments, preference shares, bonds and other interest bearing instruments and securities.

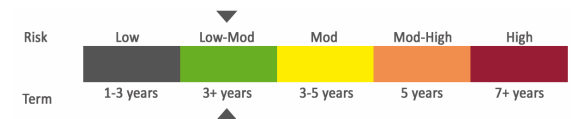
