

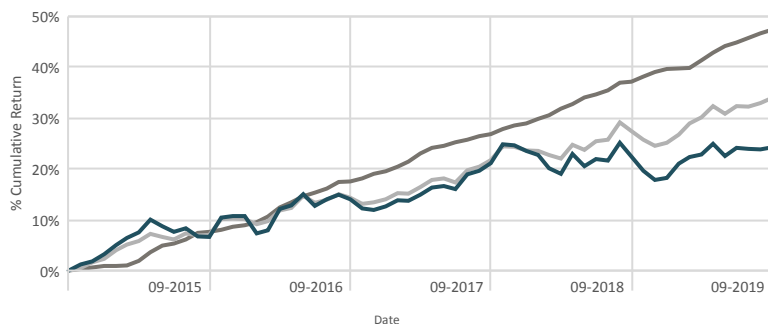
### INVESTMENT OBJECTIVE

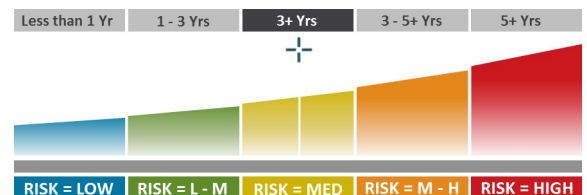

#### Medium Risk
