

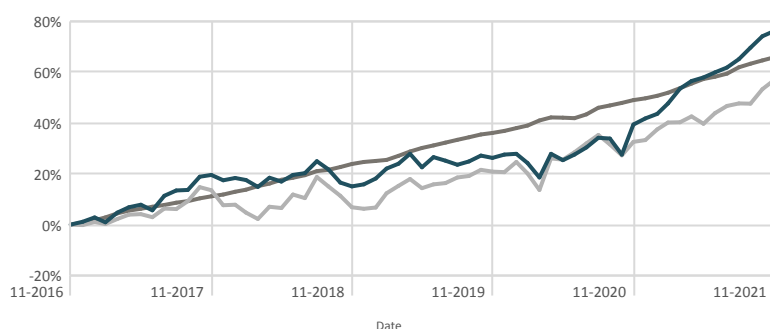
## INVESTMENT OBJECTIVE

The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments

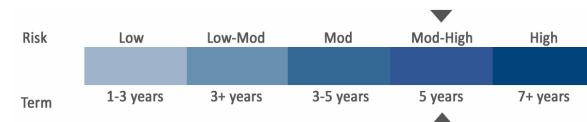

## RISK PROFILE



### Moderate - High Risk
