

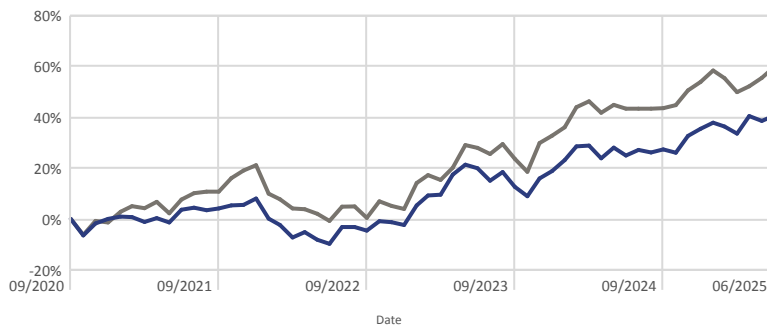
INVESTMENT OBJECTIVE

The portfolio will apart from assets in liquid form, invest solely in the participatory interests of the Lindsell Train Global Equity Fund, a sub-fund of Lindsell Train Global Funds Plc, domiciled in Ireland. The underlying portfolio invests primarily in global equity securities. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions and limits as stipulated by the Act.

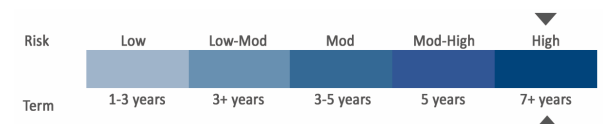
