

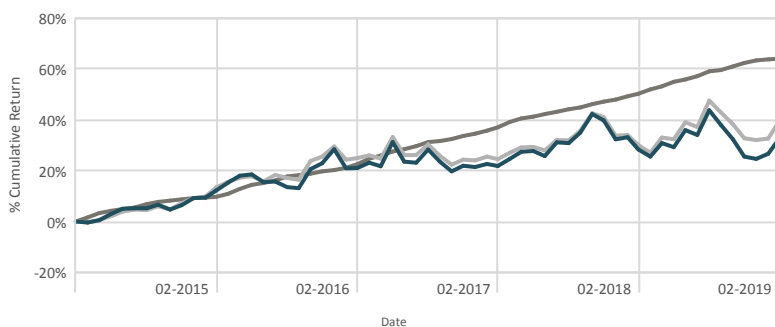
INVESTMENT OBJECTIVE

INVESTMENT UNIVERSE

The Fund aims to generate moderate to high long term total returns. The Manager has maximum flexibility in terms of asset allocation of equity securities, non-equity securities, bonds, preference shares, property, fixed interest and money market portfolios and assets in liquid form. Equity will always exceed 25%. The portfolio will be actively managed with exposure to various asset classes being varied to reflect changing economic and market circumstances, in order to maximize returns.

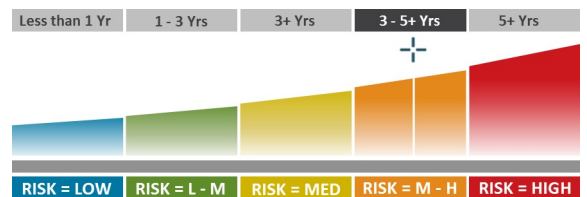

Medium - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio. In turn the expected volatility is higher than a medium risk portfolio, but less than a high-risk portfolio. The probability of losses is higher than that of a medium risk portfolio, but less than a high-risk portfolio and the expected potential long term investment returns could therefore be higher than a medium risk portfolio.
