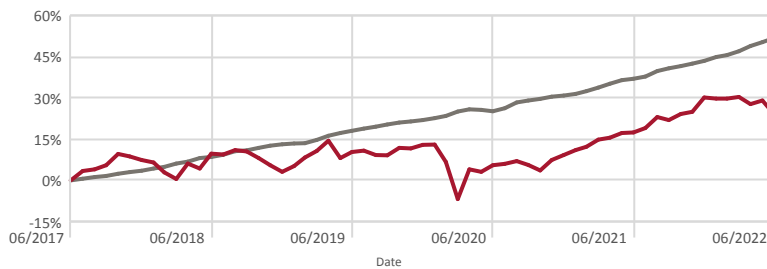
The objective is to provide investors balance between capital growth and income over the medium to long term by investing across asset classes.

INVESTMENT POLICY

The Cadiz BCI Balanced Fund aims to provide investors with a balance between capital growth and income over the medium to long term by investing across asset classes. The portfolio complies with prudential investment guidelines to the extent allowed for by the Act. The portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing securities, bonds, debentures, corporate debt, equity securities, property securities, preference shares, convertible equities and non-equity securities. The manager may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes as the Act may allow from time to time, and which are consistent with the portfolio's investment policy. The portfolio may from time to time invest in listed and unlisted financial instruments.

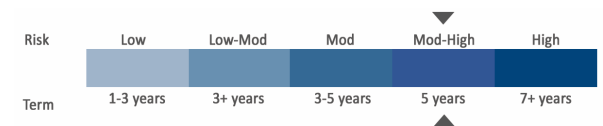

Moderate - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio.
