

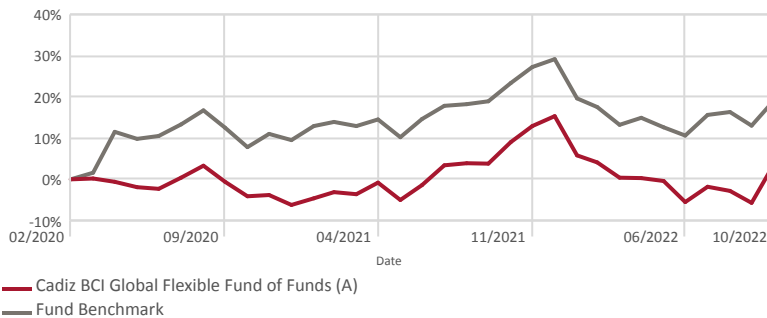
## INVESTMENT OBJECTIVE

## INVESTMENT POLICY

The Cadiz BCI Global Flexible Fund of Funds aims to provide investors with a moderate long-term total return by providing them with exposure to a diverse mix of underlying portfolios, comprising global asset classes and exposure to various currencies. The portfolio's offshore exposure exceeds 80% of its asset value. Investments to be included in the portfolio may, apart from assets in liquid form, consists of participatory interests and other forms of participation of local and global collective investment schemes. The portfolios will be investing in liquid form, equity securities, property securities, non-equity securities, preference shares debentures, bonds, fixed deposits, money market instruments and other interest-bearing securities.

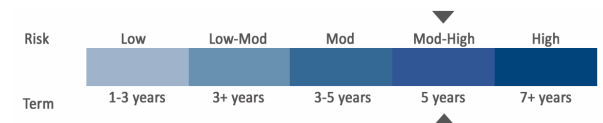

## RISK PROFILE



### Moderate - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio. In turn the expected volatility is higher than a medium risk portfolio, but less than a high-risk portfolio.
