## Fund Information

### FUND OBJECTIVE

The Cadiz Worldwide Flexible Fund seeks to provide investors with returns well above South African inflation over rolling 3 year periods. The Manager has the discretion to invest in opportunities across all asset classes globally in order to obtain the best risk-adjusted returns.

### WHAT DOES THE FUND INVEST IN?

The fund can invest in local and global investments across equities, fixed interest instruments, listed property, derivatives and cash. Investments are selected at an individual security level where the Manager considers the risk of permanent capital loss to be low, with attractive risk-adjusted return potential. Equities will generally make up the bulk of the funds' investments in order to provide high (> 6% pa) long term real returns, but the Manager has maximum flexibility in terms of asset allocation and is not precluded from varying the asset allocation to reflect the Managers view of the attractiveness of different asset classes.

### WHO IS THE FUND SUITABLE FOR?

- Investors with at least a 5 year investment horizon.
- Investors who are in their wealth accumulation phase seeking high long term real returns.
- Investors with a moderate to high risk profile.

### INVESTMENT PHILOSOPHY AND PROCESS

We apply a long term, bottom-up investment process to uncover the most attractive risk-adjusted return opportunities for the various asset classes available in local and foreign markets. Our process focuses on avoiding assets that could lose capital permanently, while ensuring the fund is well diversified.

Our equity investment approach is rooted in the belief that the market is prone to overreact to good and bad news. This causes a divergence between the current market price and what the business is worth.

We seek to take advantage of these short-term market overreactions by investing in financially sound, good quality businesses with capable management, when they are typically out of favour and attractively priced.

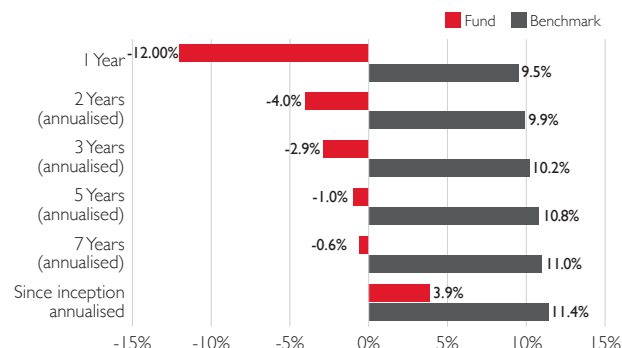

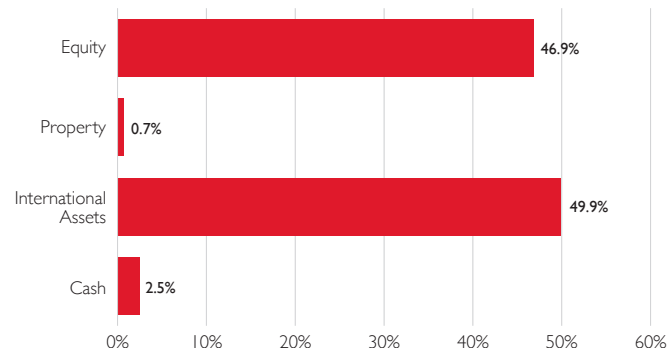

## Quarterly Fund Manager Commentary – First Quarter 2020

The Cadiz Worldwide Flexible fund declined 22.9% this quarter. The 1 year rolling return is -22.7%, with a rolling 3-year return of -6.1%. This is compared to its benchmark, which is CPI + 6%, which is 10.7% and 10.3% p.a. respectively. The Covid-19 market crash has made the near-term performance of the fund poor versus our long-term expectations.

South African equity has delivered poor long-term returns over the last 10 years, which is a combination of a high starting price as well as the lost decade of economic growth during the Zuma presidency. Current SA share prices are highly attractive and could deliver stellar returns if economic growth normalises to SA's long-term potential. Hence, while it is painful to experience the recent market sell-off, the low price improves future return prospects and instead of fleeing equity investments, we encourage clients to stick to their long-term investment plan.

Global Equity markets fell -21% in the first quarter of 2020 as COVID-19 spread rapidly from China to Europe, US and to more than 200 countries globally. This has caused economic activity to come to an abrupt halt as various social distancing and lockdown measures have been implemented to curb the spread of the disease. From China, to Europe, US and South Africa economic activity was reduced to around 20% to 40% of normal activity. This has forced the global economy into a recession.

The policy response has been unprecedented. Central banks, globally, have provided an abundance of liquidity to ensure financial markets function in an orderly manner as corporates and households access cash. Corporates need cash to pay their staff, pay rent, service interest costs and pay taxes. At the same time various governments around the world have provided extensive relief packages (greater than 10% of their GDP) to help households and corporates weather this storm. The full extent of the global economic contraction is not known and could take time to recover.

**During this global COVID-19 pandemic, we remain focused on protecting our clients from permanent capital loss while investing in good businesses that should compound your wealth over time.**

The quickest way to lose your money is when a company can't service its debt obligations. For each of our investments, we have re-interrogated the company's balance sheet and stress tested their ability to manage debt obligations and cash requirements under more extreme operating scenarios. We are pleased to report that we are comfortable with the balance sheets of all the investments we hold, which limits the risk of losing investment capital. So even though share prices are lower, these businesses should recover and be able to navigate the impacts of the lockdown and over time generate good long-term returns.

The fund continues to hold a well-diversified portfolio of global and local stocks. These are predominately quality businesses that have proven track records of weathering downturns and lasting through the cycle.

When the world finally overcomes this COVID-19 pandemic and world economies recover, different industries are likely to recover faster than others. It is hard to tell which industries or stocks will be winners in the short term, but we believe the portfolio of diverse businesses our clients are invested in have decent long-term growth prospects. This, combined with highly attractive valuations, sets up the portfolio for good long-term returns. Markets can be very volatile in the short-term, but history has shown that those that are willing to be patient and invest for the long-term, will be handsomely rewarded.

### FUND POSITIONING

The fund has 97% invested in equity, with offshore exposure at 49.3% and 0.8% in UK REITs. This is up from the 93% exposure at 31 December 2019, with offshore at 38.9% and UK REITs at 2.3%. The change in offshore exposure is largely due to the depreciation of the Rand/\$ exchange rate which offset the international equity share price decline. The UK REITs were hit hard as Covid-19 has resulted in all shopping malls closing for the duration of the shut-down. The fund also took advantage of the falling share prices at the beginning of March to improve the quality and return expectations of the fund.

The fund sold AngloGold Ashanti, while we added to Impala Platinum. We also sold Prosus and added to quality SA Inc businesses, while increasing our holding in Naspers which is trading at a larger discount to intrinsic value versus Prosus. In addition, the fund incrementally added to Woolworths, Famous Brands, Booking.com, Walgreens Boots Alliance and Swatch, taking advantage of depressed share prices.

We chose to add to existing investments rather than add new ideas this quarter, even though our analysts continue to present compelling ideas that meet our investment criteria.

We remain disciplined in sticking to our investment philosophy and process and focus intently on limiting permanent capital loss in order to grow your capital over the long term. This is achieved by investing in predominantly good businesses at attractive prices with capable management and low financial risk.

### IMPORTANT INFORMATION FOR INVESTORS:

#### Total Expense Ratio (TER)
