

INVESTMENT OBJECTIVE

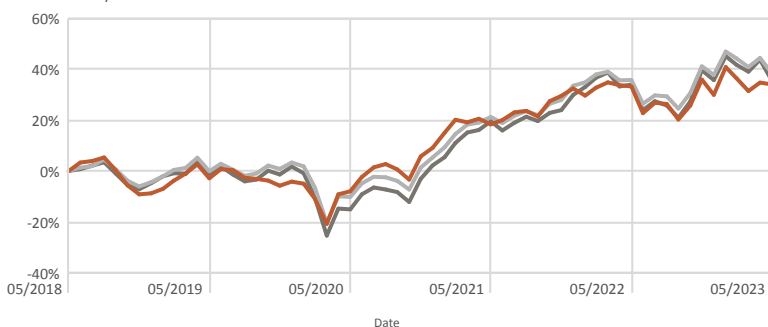
The Caleo BCI Equity Fund is a general equity portfolio that seeks to sustain high long-term capital growth.

INVESTMENT POLICY

The portfolio's investment universe consists of equity securities, preference shares, property shares and property related securities listed on exchanges, money market instruments and assets in liquid form. The portfolio may from time to time invest in listed and unlisted financial instruments. The portfolio's equity exposure will always exceed 80% of the portfolio's net asset value and its offshore exposure will be limited to maximum 25% of the portfolio's net asset value.

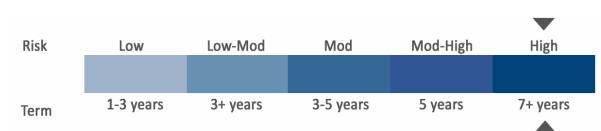
