MONTHLY COMMENTARY

The fund benchmark, the FTSE EPRA/NAREIT Developed Rental Net Total Return Index, recorded a net total USD return of 2.05% for the month of August. The best performing listed real estate market was Australia, which recorded a total USD return of 9.45% for the month. Canada recorded the lowest total USD return of -1.78%.

The best performing real estate sectors for the month were Asian Hotels (21.18%), Asian Net Lease (18.12%) and Asian Malls (15.73%). The worst performing sectors were Asian Healthcare (-9.18%), European Hotels (-8.98%), European Malls (-6.74%).

Residential regulatory news in the US was released with two pieces of legislation coming into effect. Firstly, the Governor of California signed the Tenant Relief Act of 2020 that provides heightened protection against eviction for renters until early 2021. Secondly, the Trump Administration passed an executive order until the end of 2020 to limit evictions nationally. It remains to be seen whether a continuation of supplemental employment benefits mitigates some of the impact on rental payments to be received by landlords in the interim.

Retail landlord Hammerson announced a £525m rights issue as well as the disposal of its share in VIA Outlets to existing joint venture partner APG. Both these transactions were passed by shareholders at a general meeting.

The estimated forward FAD (Funds Available for Distribution) yield for the sector is 4.70%. Relative to corporate bonds the sector looks attractively priced on both implied cap rates and expected total return spreads. Within the real estate universe, more attractively priced opportunities exist in specific real estate sectors and stocks, providing opportunities for astute active managers.

INVESTMENT OBJECTIVE

This specialist fund offers real estate focus, with global diversification. The real estate focus is through real estate securities with a specific bias towards stocks classified as investors, as opposed to developers. The investor classification is defined as those stocks that have 70% or more of their income derived from rent. The guiding principle is the ownership of real estate assets, primarily to earn rental related income streams which provide a stable underpin to long term returns. Global diversification is across geographic regions, currencies, countries and real estate types. The intention is to provide an attractive risk-adjusted return to form part of a multi asset class portfolio. The fund benchmark is the FTSE EPRA/NAREIT Developed Rental Index, which comprises of stocks in the following regions: United States, Canada, UK, Europe, Japan, Hong Kong, Singapore, Australia and New Zealand.




UNDERLYING FUNDS GEOGRAPHIC ALLOCATIONAS AT 31 AUGUST 2020

UNDERLYING FUNDS SECTORAL ALLOCATION AS AT 31 AUGUST 2020




