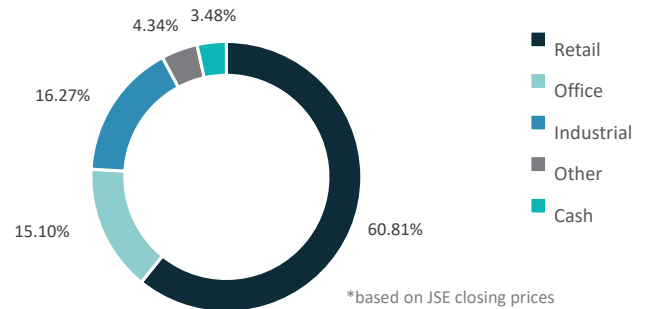

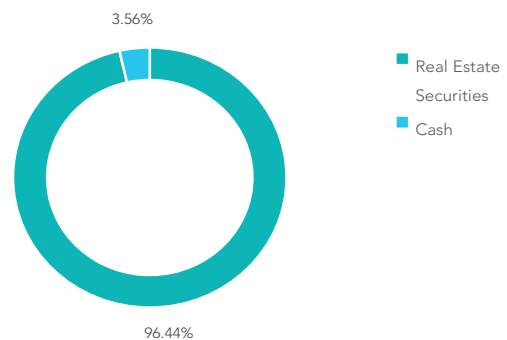

SPECIFIC FUND RISK
