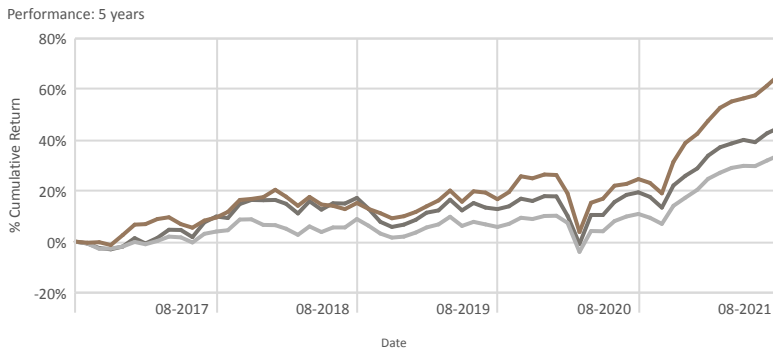
INVESTMENT OBJECTIVE

The Centaur BCI Flexible Fund is a flexible portfolio that aims to provide investors with high long term capital growth.

INVESTMENT POLICY

The portfolio may invest in global and local equity securities, government bonds, corporate bonds and inflation linked bonds, debentures, property securities, property related securities, preference shares, non-equity securities, interest bearing securities, money market instruments and assets in liquid form. The manager may include forward currency swaps, interest rate and exchange rate swap transactions.

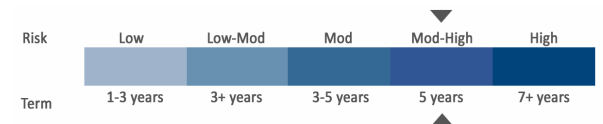

Moderate - High Risk
