


## INVESTMENT OBJECTIVE

The Consilium BCI Flexible Fund is a flexible portfolio, having the primary objective of providing investors with long term capital growth and a reasonable level of income.

## INVESTMENT POLICY

The primary objective of the portfolio is to provide investors with long term capital growth and a reasonable level of income. In achieving this objective, the investments to be acquired for the portfolio may comprise of a mix of equity securities, property shares, property related securities, non-equity securities, government and corporate bonds, preference shares, money markets instruments and assets in liquid form. The portfolio may from time to time invest in listed and unlisted financial instruments. The manager may also include forward currency, interest rate and exchange rate swap transactions.



## Moderate - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio.
