



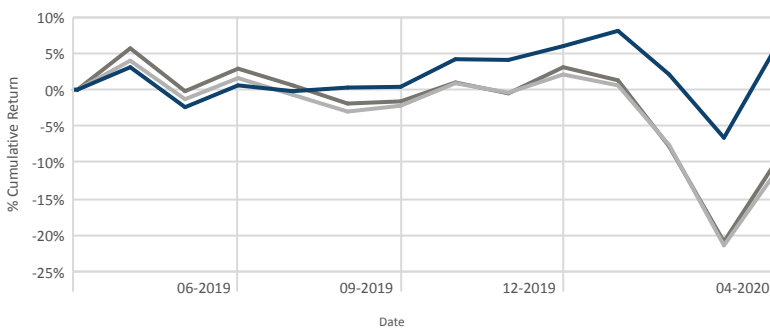
INVESTMENT OBJECTIVE

The Cratos BCI Equity Fund is a general equity portfolio that seeks to sustain high long-term capital growth.

INVESTMENT POLICY

The portfolio's investment universe consists of equity securities, preference shares, property shares and property related securities listed on exchanges and assets in liquid form. The portfolio may from time to time invest in listed and unlisted financial instruments, in accordance with the provisions of the Act, and the Regulations thereto, as amended from time to time, in order to achieve the portfolio's investment objective. The portfolio's equity exposure will always exceed 80% of the portfolio's net asset value.

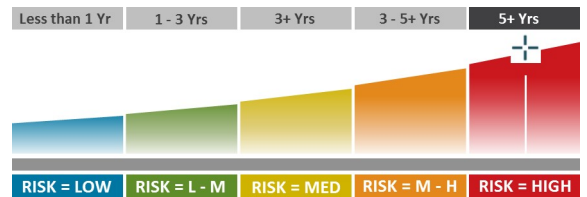

High Risk
