### **INVESTMENT OBJECTIVE**

The Dinamika BCI Conservative Fund of Funds is a cautious managed fund of funds portfolio with the primary investment objective to provide the investor with a high level of income and stable capital growth.

### **INVESTMENT POLICY**

Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the manager and trustee of a sufficient standard to provide investor protection at least equivalent to that in South Africa and which is consistent with the portfolio's primary objective, investing in amongst others, equity securities, property securities, non-equity securities, money market instruments, preference shares, bonds and other interest bearing instruments and securities.


