
INVESTMENT OBJECTIVE

The Evolve BCI Conservative Fund is a cautious risk profile portfolio with the objective to provide investors with a high level of income and stable capital growth.

- INVESTMENT UNIVERSE

To provide a limited level of capital protection, the portfolio's equity exposure may be as high as 40% of the portfolio's net asset value. The manager may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes as the Act may allow from time to time. and which are consistent with the portfolio's investment policy. The portfolio may from time to time invest in listed and unlisted financial instruments. The manager may also include forward currency, interest rate and exchange rate swap transactions.


