## INVESTMENT OBJECTIVE

The Fairtree Equity Prescient Fund is an actively managed domestic general equity fund with a focus on maximizing total returns for the client. The Fund's objective is to offer medium to long-term capital growth. The Fund aims to actively invest in equities with a level of capital appreciation and income potential and to outperform its benchmark, the FTSE/JSE Capped Shareholder Weighted All Share Total Return Index (CAPPED SWIX) over the long term.

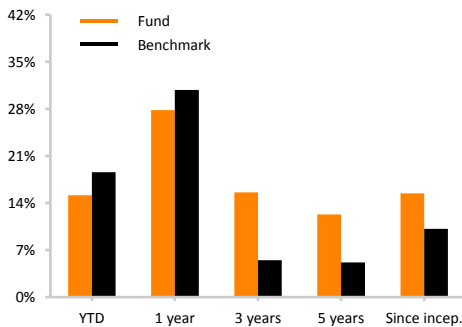
## INVESTMENT POLICY

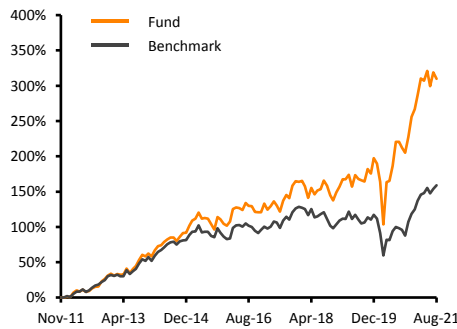
## RISK INDICATOR

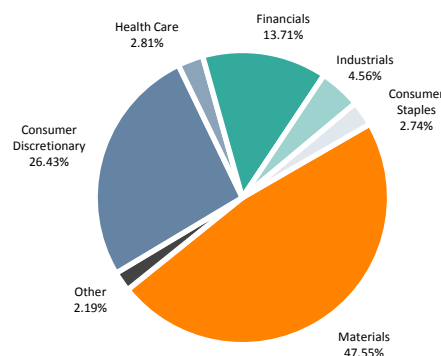

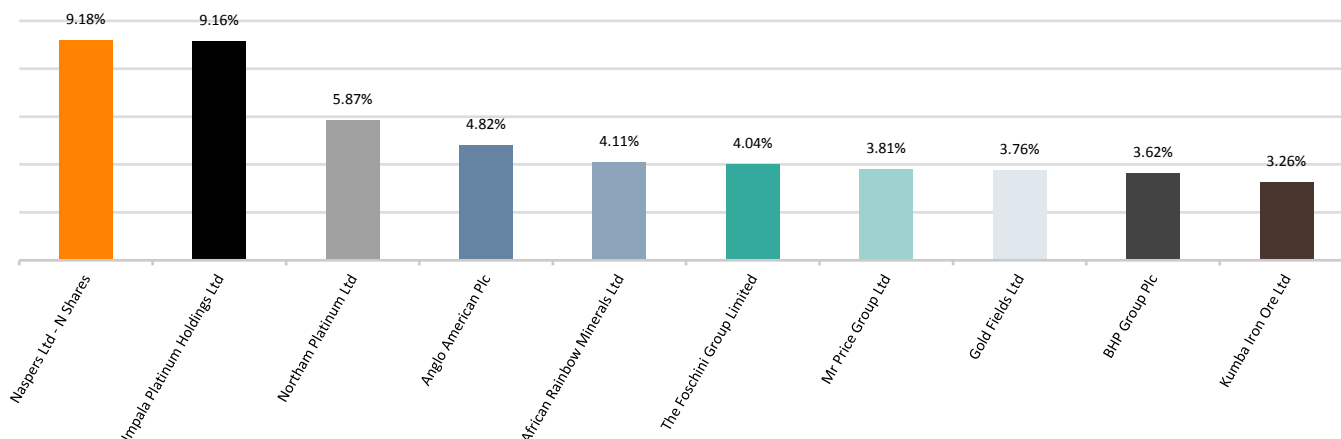

## MARKET COMMENTARY

The FTSE/JSE All Share Index (ALSI) decreased by 1.7% during August 2021. FTSE/JSE Shareholder Weighted Index (SWIX) increased by 0.4% and FTSE/JSE Capped Shareholder Weighted Index (Capped SWIX) increased by 2.0%. The Rand strengthened slightly by 0.5% during the month. Resources and Industrials decreased by 4.7% and 4.4% respectively, while Financials increased by 11.4%.

During August, Bonds increased by 1.7% and Cash returned 0.3%. The MSCI Emerging Market Index increased by 2.4% (USD), underperforming the MSCI World Index which increased 2.3% (USD). The MSCI South Africa index increased by 0.6% (USD).

Through August, Iron Ore fines decreased 14.3% to \$153.1/t and Thermal Coal increased by 9.0% to \$145.4/t. Brent Crude oil decreased by 4.0%, ending the month on \$71.6/bbl. Gold was down 0.03% to \$1813.6/oz and Platinum decreased by 3.4% to \$1015.8/oz. Palladium decreased by 7.2% to \$2470.9/oz.

Over the past month, the combination of oil weakness, global spreading of the Delta variant and imminent fiscal drag have created a backdrop ideal for a growth scare. More generally, the global slowdown concern coincided at a time when the US authorities were trying to take their foot off the monetary and fiscal accelerator.

China's latest macro numbers are soft and has confirmed economic slowdown which only fuelled poor growth sentiment by the market. The economic weakness was exacerbated a lockdown due to a mini outbreak of the delta variant, but is primarily due to the lagged impact of policy tightening in previous months. The global growth softening created a risk off environment and we saw a stronger dollar with resultant commodity weakness.

Our overweight resource position was the main detractor of performance with most commodities coming under pressure. The Jackson Hole speech gave the market some comfort with no new news regarding tapering; and in the last week of August, commodity weakness abated but not enough to offset full performance detraction from our PGM and gold position. That said we are of the view that US policy accommodation has peaked and we should see a softer dollar going forward which will benefit commodities and emerging markets.

The VIX Index (Volatility or 'Fear' Index) decreased 9.7% during the month.

The fund's performance was positively impacted by positions in Old Mutual (18.9%), Woolies (14.1%), Sanlam (11.3%), Capitec (16.7%) and Stanbank (20.4%) while Impala (-15.6%), Naspers (-12.1%), Northam (-13.5%), ARM (-13.3%) and AngloGold (-16.5%) detracted from performance.

The fund invests in a number of focussed strategies. Amongst these strategies we are overweight Cyclical (Diversified Mining, Platinum), Defensive (Gold Mining) and Value (Property, Local Consumer Discretionary, Financials, Industrials).

## GLOSSARY

**Annualised Performance:** Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest Performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**Alpha:** Denoted the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Max Gain:** Largest increase in any single month.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

**High Water Mark:** The highest level of performance achieved over a specified period.

**Total Expense Ratio (TER%):** The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

**Performance fee incl. in TER (%) PF (%):** The Performance Fee is a payment made to the Fund Manager for generating positive returns and is generally calculated as percentage of investment profits, often both realized and unrealized.

**Transaction Costs (TIC%):** The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

**Total Investment Charges TIC (%) = TER (%) + TC (%):** The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

## SPECIFIC RISK

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

The Portfolio is more diversified than the benchmark, thus holding smaller positions in the largest capitalisation stocks than the benchmark. This comes with the risk of more volatile relative returns to the broader market when the largest stocks in the benchmark outperform. We believe however that this strategy of holding a more diversified portfolio results in lower single stock risk, and whilst there may be periods of underperformance when the large cap stocks rally, we firmly believe in efficient risk management on an absolute basis. The strategy is also exposed to various factors driving investment performance, for example Value and Momentum, and these factors may also experience periods of relative underperformance. Global research has shown however, that consistent long term exposure to these factors lead to investment reward. This portfolio is permitted to invest in foreign securities which may have additional risks (FX Movements for example). However, the portfolio does not currently hold any foreign securities and the manager does not intend on exposing the portfolio to any foreign securities going forward.
