When investing in derivatives, the manager will adhere to the prevailing regulations.



Risk Profile

Glossary Terms

Capital growth

As the company grows, and the expectation of improved profits increases, the market price of the share will increase and this translates into a capital gain for the shareholder. Similarly, negative sentiment about the company will result in the share price falling. Shares/equities are usually considered to have the potential for the highest return of all the investment classes, but with a higher level of risk i.e. share investments have the most volatile returns over the short term. An investment in this type of asset should be viewed with a 7 to 10 year horizon.

Fundamental analysis

This is a method of evaluating a share that involves attempting to measure its intrinsic value by examining related economic, financial and other qualitative and quantitative factors. Fundamental analysts attempt to study everything that can affect the share's value, including macroeconomic factors (like the overall economy and industry conditions) and company-specific factors (like financial statements, cashflow and management).

Total Expense Ratio (TER)

This is the total costs associated with managing and operating an investment (excluding administration, financial planning and servicing fees). These costs consist primarily of management fees and additional expenses such as trading fees, legal fees, auditor fees and other operational expenses. The total cost of the fund is divided by the fund's total assets under management to arrive at a percentage amount, which represents the TER.

Volatility

Volatility is a measure of 'risk', and refers to the extent to which the price of an investment or fund fluctuates over a certain period of time. Funds with a high volatility usually offer the potential for higher returns over the longer term than low volatility funds.

Portfolio Manager Comment

As at 30 September 2022

The quarter saw our returns cement themselves firmly in the Black relative to the benchmark and peers. We can also say that the most decisive characteristic of Quality, namely, capital allocation contributed to outperformance. Over the past 12months, dividends contributed more than 100% of our returns (-5.61% in capital loss vs. +6.54% in dividends earned). High Quality companies do not just possess competitive advantages, they also optimize cash flow from operations for returning capital to shareholders (ordinary and special dividends, share buy backs) and balance sheet deleveraging before investing for growth. For instance, for every R1 Clicks invests in capex, it returns R2 to shareholders by way of dividends and share buy-backs. In contrast, for every R1 Pick n Pay invests in capex, it returns 50c to shareholders. It is these capital returns that drove our outcomes over the past 12 months. In short, a normalizing monetary policy environment makes this is now a stock picker's market. The momentum of a single sector leading the market upwards is now in the rear-view mirror. We are confident that the sacrifices we made in the past to stick to our style will continue to stand us in good stead.
