

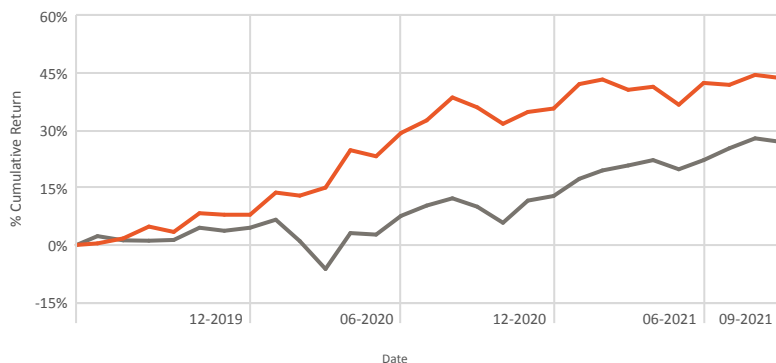
INVESTMENT OBJECTIVE

The Innovation BCI Worldwide Equity Fund is an aggressive risk profile portfolio that aims to deliver a high long-term capital growth through domestic and global investments. The portfolio's minimum equity exposure will be 80% at all times.

INVESTMENT POLICY

The manager may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes as the Act may allow from time to time, and which are consistent with the portfolio's investment policy. Territories other than South Africa, participatory interests or any other form of participation in portfolios of these schemes will be included in the portfolio only where the regulatory environment is. The portfolio may from time to time invest in listed and unlisted financial instruments, in accordance with the provisions of the Act, and the Regulations thereto. The manager may also include forward currency, interest rate and exchange rate swap transactions for efficient portfolio management purposes. For the purpose of this portfolio, the manager shall reserve the right to close the portfolio to new investors on a date determined by the manager. This will be done in order to be able to manage the portfolio in accordance with its mandate. The manager may, once a portfolio has been closed, open that portfolio again to new investors on a date determined by the manager.

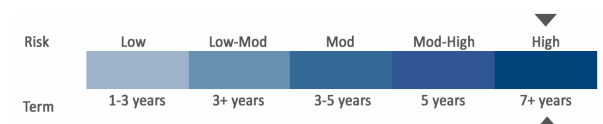
