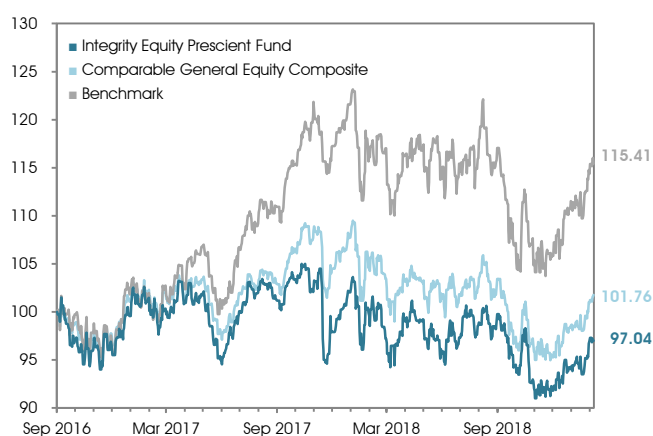

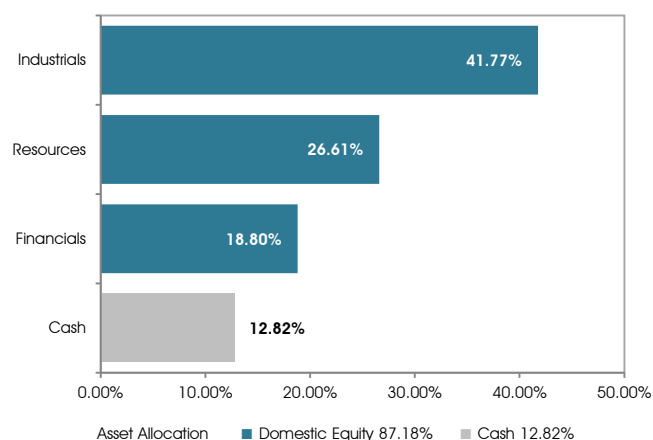

Portfolio Description

The primary objective of the portfolio is to achieve long term capital appreciation by investing in a diversified portfolio of **South African listed equities**. The portfolio manager acquires local equities at levels below the assessment of the companies' fair values. The portfolio manager also takes cognisance of worldwide economic, sector and investment trends to tilt the portfolio towards attractive sectors and companies. The Integrity Equity Prescient Fund is required to invest a minimum of 80% of the portfolio in equities at all times and is therefore suitable for investors with an investment horizon of five years or longer.

Integrity diligently follows a **value investment philosophy and process**. This is the same investment philosophy and process applied in managing the Integrity Local Equity Strategy, with track record since 5 August 2011.

A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TERs. During the phase in period TERs do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impact Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

The Manager retains full legal responsibility for any third party named portfolio. Please note that all documents, notifications of deposit, investment, redemption and switch applications must be received by Prescient by or before 13:00 (SA), to be transacted at the Net Asset Value price for that day. Where all required documentation is not received before the stated cut off time Prescient shall not be obliged to transact at the Net Asset Value price as agreed to. Funds are priced at either 15:00 or 17:00 depending on the nature of the Fund. Prices are published daily and are available on the Prescient website.

Performance has been calculated using net NAV to NAV numbers with income reinvested. The performance for each period shown reflects the return for investors who have been fully invested for that period. Individual investor performance may differ as a result of initial fees, the actual investment date, the date of reinvestments and dividend withholding tax. - ii. No index trackers, no Shari'ah compliant funds, no multi-managed funds, no institutional funds, no funds with fund size not exceeding the statutory minimum limit at any point during the period since 5 August 2011;
- iii. Funds with specifically noted non-comparable investment philosophies – specifically growth, SRI, equity income, quantitative and "growth at a reasonable price" funds are excluded; and
- iv. All funds with offshore allocations are excluded.

Annualised performance: Annualised performance shows longer-term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The Net Asset Value represents the assets of a Fund less its liabilities.
