## Portfolio profile

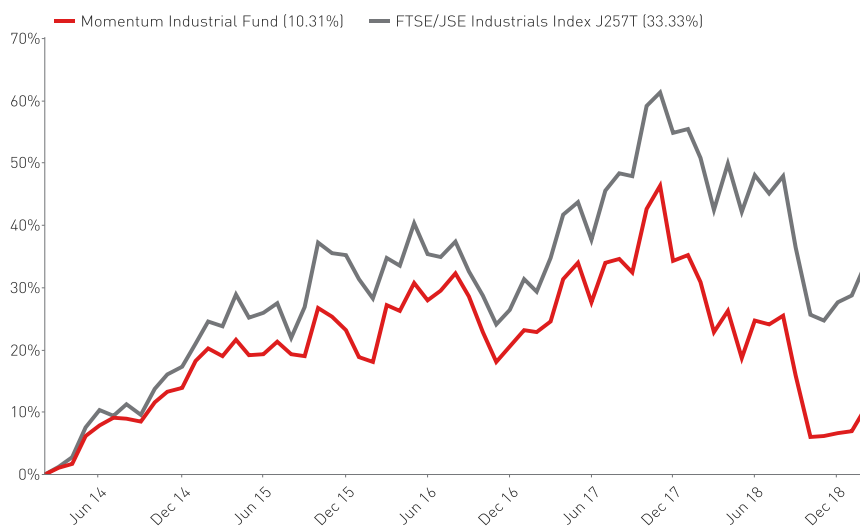
The Fund is a largely domestic equity portfolio that aims to maximise returns over the FTSE/JSE Industrials Index over time. The portfolio is suited to investors with a high risk profile with a tolerance for capital volatility over the short to medium term and a five year or more investment horizon.

## Investment strategy

The Fund invests in stocks falling within the industrial sector of the FTSE/JSE. Equity will comprise a minimum of 80% of the portfolio. Offshore allocations of up to 25% and an additional 5% in Africa provide further return opportunities and diversification benefits.

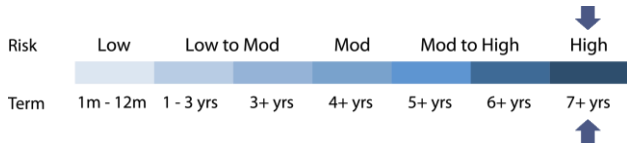

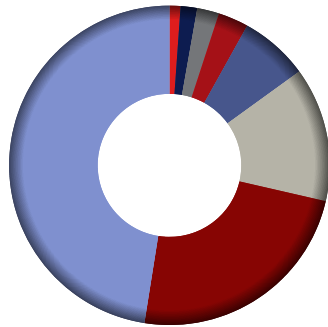

## Portfolio objective/investment policy

The Momentum Industrial Fund is a specialist portfolio predominately focusing on the industrial sector of the JSE and will seek to achieve an investment medium for investors that will aim to achieve high capital growth as its primary objective. In order to achieve this objective, the portfolio will, apart from assets in liquid form, invest in equity securities, preference shares, debenture stock, debenture bonds, convertible bonds traded on recognised stock exchanges, unsecured notes and any other security listed on any recognised stock exchange which is considered consistent with the portfolio's primary objective and that the Act or the Registrar may allow from time to time, all to be acquired at fair market value. The portfolio may from time to time invest in financial instruments in order to achieve the portfolio's investment objective. The manager may also include unlisted forward currency agreements, interest rate and exchange rate swap transactions. The portfolio may also invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes as the Act may allow from time to time, and which are consistent with the portfolio's investment policy. Where the aforementioned schemes are operated in territories other than South Africa, participation in portfolios of these schemes will be included in the portfolio only where the regulatory environment is of sufficient standard to provide investor protection at least equal to that in South Africa.

## Portfolio limits and constraints

- Maximum exposure limits as per the ASISA fund classification structure.
- Maximum 25% offshore exposure plus max 5% exposure in Africa.
- Minimum of 80% of the portfolio must be in shares in the Industrials sector of the JSE or similar sector of an international stock exchange.
- Maximum of 10% of the portfolio may be invested in shares outside the Industrials sector to allow for the inclusion of companies that conduct similar business activities but are not classified in the Industrials sector.
