



Specific Fund Risks

Annualised performance: Annualised performance is the average return per year over the period. Duration: This is a measure of risk for funds which invest in bonds as it predicts the sensitivity of the value of a fund's portfolio given changes in interest rates. The higher the value the greater the volatility of the fund's performance resulting from changes to interest rates. The Modified duration is shown. Maximum drawdown: The largest peak to trough decline during a specific period of an investment. NAV: The Net Asset Value (NAV) represents the value of the assets of a fund less its liabilities. Risk profile: A number on a scale of 1 to 7 based on how much the value of a fund has fluctuated over the past 5 years (or an estimate if the fund has a shorter track record). A rating of 1 represents the

risk but potentially higher rewards.

Total Expense Ratio: TER includes the annual management fee, performance fee and administrative costs and includes VAT but excludes portfolio transaction costs (except in the case of an entry or exit charge paid by a fund when buying or selling units in another fund) expressed as a percentage of the average daily value of the

lower end of the risk scale with potentially lower rewards available whilst a rating of 7 reflects higher
