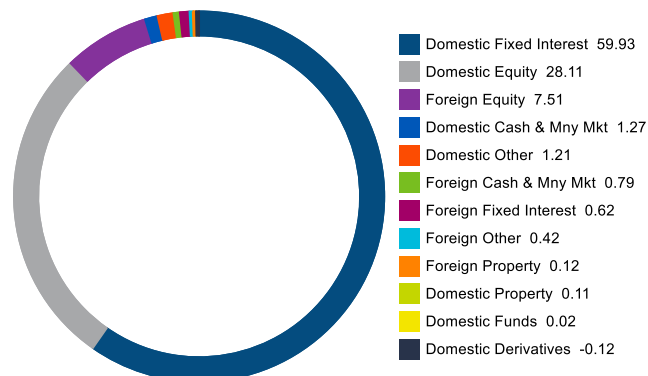

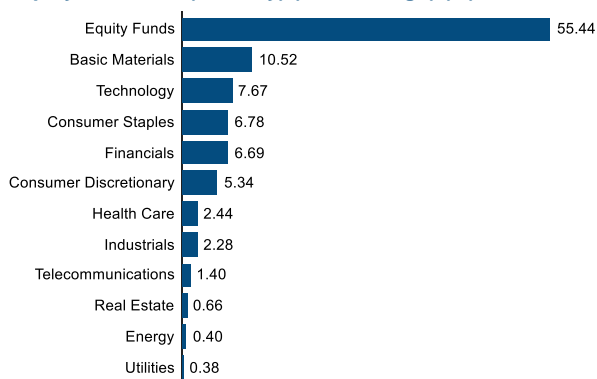

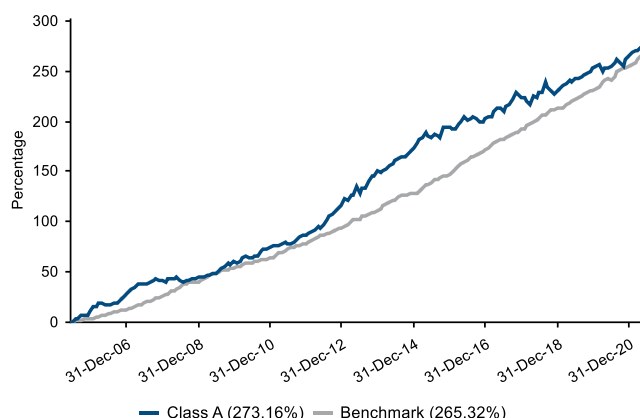

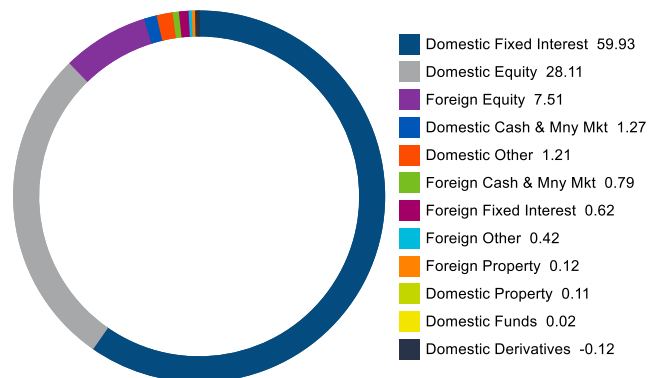

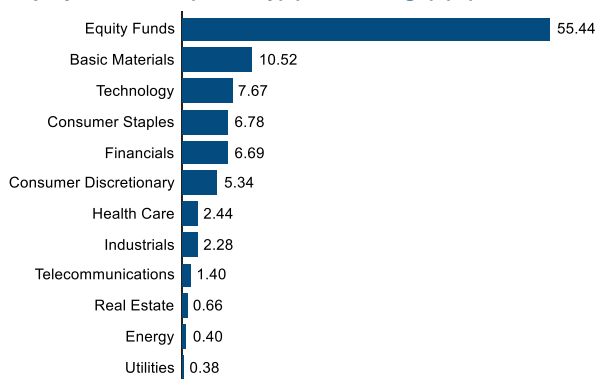

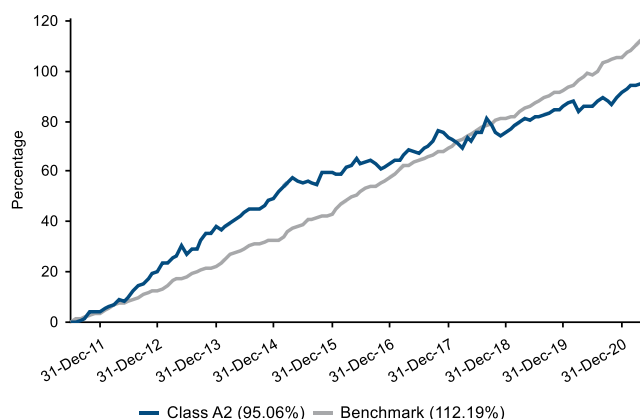

Pieter subsequently became Managing Director of Gins Global Index Funds and has established himself as a reputable fund manager at Noble Private Portfolios since 2002.

Market overview

Since our last market overview, the market has rallied significantly. However, economic activity has not followed.

It is very dangerous to chase recent performance because there is no guarantee that what has worked over the last 5 years will work for the next 5 years.

Economists continue to mark up their expectations for growth but care should be taken to keep a balance between equities and interest-bearing instruments.

Investors should stick to capital preservation, stay away from chasing recent performance and keep on making informed decisions.
