
#### Cumulative performance (%) from Launch



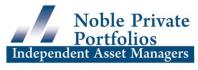
