ESG FUND RATING

FUND OBJECTIVE

The fund is strictly managed in accordance with Shari'ah (Islamic Law) and therefore does not invest in shares of companies whose core business involves dealing in alcohol, gambling, non-halaal foodstuffs or interest-bearing instruments. The Shari'ah Supervisory Board oversees adherence to the applicable Shari'ah principles. This fund specifically adheres to the standards of the Accounting and Auditing Organisation for Islamic Financial Institutions (AAOIFI) as interpreted by the Shari'ah Supervisory Board.

WHO IS THIS FUND FOR?

This fund is suited to investors with a long-term investment horizon seeking to maximise growth in a Shari'ah compliant fund. They are able to accept the risks associated with equity funds and also the mandate risk of a more limited investment universe.

NON-PERMISSIBLE INCOME

Incidental income deemed to be non-permissible is paid to the charitable trust elected by the Shari'ah Supervisory Board in line with the principles of Shari'ah and the supplemental deed of the fund. Non-permissible income does not form part of the investor's income.

INVESTMENT MANDATE

The fund is a Shari'ah compliant fund which provides investors with cost-effective access to a broad spectrum of local and international listed investments.

REGULATION 28 COMPLIANCE

The fund aims to achieve long-term inflation-beating growth, and therefore may hold a higher allocation to equities than what is allowed in terms of Regulation 28 of the Pension Funds Act. This fund is therefore not Regulation 28 compliant.



Globally, investors experienced mayhem as there were dramatic moves in numerous markets, which demonstrates the concerns as recession fears grow. Equity market returns in September were negative in the US and Europe. The MSCI World Index and the S&P 500 were down 6.6% and 5.3% respectively whilst the FTSE 100 was down 12.1% for the quarter ending September 2022.

We witnessed 300 basis points (bps) of interest rate hikes in the US this year. Higher inflation is persisting while the US Federal Reserve is playing catch-up as we saw 75bp hikes replacing 50bp hikes. There is a "higher for longer" expectation while the central bank frontloading theme is playing out. The impact of this should push the economy into recession, probably later than investors expect. The same story is playing out in Europe – however, with the additional energy crisis concern.

Chinese expectations regarding housing and fixed investment continue to weigh on expectations of any economic recovery.

Confidence is lacking in Chinese fiscal policy. As this is key to any economic recovery there is an upside risk.

Back at home, South African equities were no different due to the global effect, alongside electricity cuts taking their toll. The South African Reserve Bank (SARB) kept pace with an expected 75bp hike. Investors will now focus their attention on the Medium-Term Budget and the ANC's conference in the next few months. The All Share Index (ALSI) delivered negative 1.92% for the quarter ending September 2022.

Against this challenging backdrop, the fund returned a positive 0.7% for the year ending September 2022.

Globally, tighter fiscal conditions imply a risk-off environment with safe havens and tactical opportunities. The US government's preferred metric is PCE (personal consumption expenditures), which rose by 6.2% from a year ago in August. Interestingly, wages are not

keeping pace, as the hourly wage increased by 5.2%. Therefore, people are paying more but not making more. In saying that, shoppers would eventually reach their breaking point and just start buying essentials. This should lead to lower prices and slower economic growth.

Locally, we saw the South African Consumer Confidence Index (CCI) decelerate substantially. In addition, we do believe we are not at the end of the interest rate hiking cycle. This implies tighter wallets for consumers.

Companies with attractive free cash flow yields, pricing power, and healthy balance sheets have historically performed better through economic slowdowns and recessions.

We are confident that the portfolio is well positioned to navigate market uncertainty and create long-term wealth for our clients.
