FUND OBJECTIVE

The fund aims to deliver a regular income and to outperform bank deposits over time, while preserving capital. The fund has never experienced a negative return over any calendar month since inception.

WHO IS THIS FUND FOR?

This fund is suited to investors who want a liquid investment that delivers a regular income and/or maximum capital protection, but who understand that their investment is unlikely to keep pace with inflation if held in the long term.

INVESTMENT MANDATE

The fund invests in money market securities with a maturity of less than 13 months. The fund's weighted average duration may not exceed 90 days.



The fund has a Global Credit Rating (GCR) of AA+.

The next review date is 30 June 2025.

REGULATION 28 COMPLIANCE

The fund is not required to be Regulation 28 compliant in terms of its Deed, but the fund manager is mandated to comply with Regulation 28 on a day-to-day basis.





PORTFOLIO MANAGERS COMMENTARY AS AT 31/03/2025

FUTUREGROWTH ASSET MANAGEMENT

The US Federal Reserve (Fed) held two FOMC meetings in the first quarter of 2025. In the 29 January meeting, the Fed unanimously resolved to keep interest rates on hold and continue to reduce its securities holdings, with economic activity remaining robust and unemployment levels remaining low. In its three previous meetings, the Fed had implemented three policy rate cuts of 25bps each, this therefore marked a pause in the monetary policy easing cycle. In the 19 March meeting, the Fed unanimously voted to keep the policy rate on hold and slow the pace of balance sheet run-off, with labour market conditions remaining robust, and inflation levels remaining contained. Trump administration policies such as tariffs and resultant inherent recession and inflationary risks were highlighted as an area of economic concern looking ahead.

In the 30 January MPC meeting, the South African Reserve Bank (SARB) announced a reduction in the repurchase rate by 25bps from 7.75% to 7.5%, with headline inflation cited as well contained in the immediate term. At

this point in time, the inflation print was at 3%, which is well below the midpoint (4.5%) of the inflation target band. The SARB noted that risk to the inflation outlook was to the upside, while risks to the growth forecast remained balanced at the time. The MPC voting split at this meeting was four members voting for a cut, while two members voted for rates to remain unchanged. Fast-forward to the 20 March MPC meeting, it again decided to keep the repurchase rate at 7.5%, with headline inflation still relatively well contained at the time and printing at 3.2%. This pause in the rates' cutting cycle was influenced by a highly uncertain global economic environment, led by the Trump administration 'America first' policies. Both local growth and inflation forecasts were revised marginally lower in the immediate term, with risks to the downside and upside, respectively.

The 12-month JIBAR rate marginally decreased over the period, ending the quarter at 8.092% after opening the quarter at 8.125%. Relative to this, 3-month Jibar decreased from 7.75% at the beginning of the quarter to 7.558%

at the end of the quarter. This Jibar curve flattening is in line with the local forward rate curve flattening, signalling a shallow interest rate cutting cycle during 2025. The treasury bill and bank NCD curves remained flat, with limited term premium for investing in the longer end of those curves. Short term funding requirements from local banks remain subdued, with 1-year Jibar-linked NCD's offered at 40bps above Jibar by the local big four banks.

The Futuregrowth interest rate team macroeconomic view is that South Africa has transitioned away from the top of the inflation and interest rate cycles, with the cutting cycle having commenced in quarter three of 2024. This cutting cycle has now paused and forecasted to be shallow in 2025 if resumed. This current pause is a function of a very uncertain global economic and geopolitical backdrop, adding increased volatility to markets. Portfolio risk positioning therefore remains neutral to benchmark, with exposure to term credit remaining a key avenue for yield enhancement.

Daily prices are available on the public website and in the media.
- Unit trusts are traded at ruling prices, may borrow to fund client disinvestments and may engage in scrip lending. The daily ruling price is based on the current market value of the fund's assets plus income minus expenses (NAV of the portfolio) divided by the number of units on issue.
