## INVESTMENT OBJECTIVE

The investment objective of the Platinum BCI Income Provider Fund of Funds is to provide investors with a high level of sustainable income and stability of capital invested

## **INVESTMENT POLICY**

The portfolio will be managed in compliance with prudential investment guidelines for retirement funds in South Africa to the extent allowed for by the Act. To provide a limited level of capital protection, the portfolio's equity exposure may be as high as 40% of the portfolio's net asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consist of equity securities, property shares, property related securities, non-equity securities, interest bearing instruments and securities, preference shares and money markets instruments.
