
# **INVESTMENT OBJECTIVE**

The Point3 BCI Balanced Fund of Funds is to offer investors a moderate to high long term total return.

# **INVESTMENT POLICY**

The portfolio will have investment instrument exposure across multiple asset classes in order to ensure portfolio diversification and therefor risk reduction. On a look through basis, the portfolio's equity exposure can range between 0% and 75% of the portfolio's asset value. Investments to be included in the portfolio will consist of assets in liquid form, excluding money market instruments, as well as participatory interests and other forms of participation of local and global collective investment schemes, investing in amongst others equity securities, property securities, non-equity securities, money market instruments, preference shares, bonds and other interest bearing instruments and securities. The intention of the fund is not to exceed an equity allocation of 65%.
