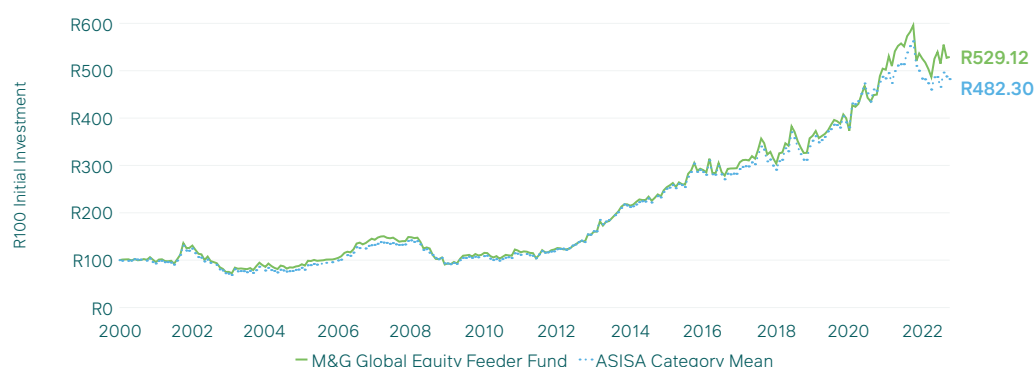

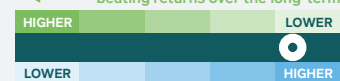

Fund objective

The Fund's objective is to provide investors with capital growth over the long-term by investing in a diversified portfolio of global equity securities.

Investor profile

Investors seeking long-term capital growth from global equity securities. The recommended investment horizon is 7 years or longer. Although the Fund's investment universe is global, units are priced in rands. Investors can therefore invest without having to personally expatriate rands.

Investment mandate

The Fund is a feeder fund and, other than assets in liquid form and currency contracts, invests only in one underlying fund – the M&G Global Equity Fund. Quantitative analysis of individual companies, proprietary data analysis and machine learning are used to identify securities for potential inclusion by the fund managers. The Fund has exposure to a diversified portfolio that may include common stocks and shares, depository receipts, REITs, other collective investment schemes and financial derivative instruments.

Fund commentary

In December, market sentiment turned bearish again after two months of risk-on sentiment, as selling pared October-November gains. Developed equity and bond markets ended the year in negative territory, bringing to an end the long bull market that started with the recovery from the 2008 Global Financial Crisis. In the US, the Federal Reserve (the Fed) maintained its tough anti-inflationary stance, hiking interest rates by 50bps and lifting its interest rate forecast for end 2023 by 0.5%, to 5%-5.25%. US GDP growth forecasts now centre around less than 1.0% for 2023, with data indicating that the US housing market is already slowing meaningfully. However, consensus projections are for a relatively mild and brief recession lasting the first three quarters of 2023. Meanwhile, US CPI fell to 7.1% y/y in November, from 7.7% in October. In the UK, the Bank of England (BoE) raised its key interest rate by 50bps to 3.5%. The Bank indicated more hikes are likely into 2023 in its bid to curb inflation, despite the negative impact on growth. The BoE still believes the economy is headed for a recession lasting for all of 2023, with GDP projected to contract by 1.4% in 2023. Finally, Prime Minister Rishi Sunak's sweeping new budget plan was greeted more favourably than Liz Truss's disastrous mini budget, proposing higher taxes and lower spending to reduce the government's debt levels. Turning to the Euro Area, the European Central Bank (ECB) followed the US and UK with its own 50bp hike in December, suggesting similar-size hikes at its next two meetings. Eurozone inflation fell to 10.1% y/y in November as energy costs eased. The ECB still expects a short and shallow recession in 2023 as the energy crisis is seen weighing heavily in the shorter-term: it downgraded its expectations for the region's GDP growth to 0.5% in 2023 (from 0.9% previously).

In China, the government responded to widespread protests against its strict zero-Covid policy by removing almost all restrictions. However, this came as a new wave of Covid infections was spreading, with some projections that it could result in upwards of 1 million deaths. The People's Bank of China (PBoC)'s benchmark lending rates were unchanged in December, however the Bank pledged to support domestic demand and is working together with the government to stimulate growth. Meanwhile, consensus forecasts for China's economy call for only 3.3% GDP growth in 2022, far below the government's 5.5% target. Looking at global equity market returns (in US\$), emerging markets outperformed developed markets, with the MSCI Emerging Markets Index returning -1.4% and the MSCI World Index -4.2%. Among developed markets, the S&P 500 returned -5.8%, while the Dow Jones Industrial Average delivered -4.1% and the technology-heavy Nasdaq Composite posted -8.7% (in US\$). The UK's FTSE 100 returned -0.5% and Japan's Nikkei 225 delivered -1.2% (in US\$). The rand was flat against the US dollar, but weakened 3.0% against the euro and 0.8% against the pound sterling.

A key attribute of portfolio construction within the fund is that active country, currency and industry exposures are constrained to ensure that style and idiosyncratic stock risk are the main drivers of active returns. The fund's active exposure to high residual volatility, low profitability and small size companies were the main detractors in December, partially mitigated by low momentum and cheap valuation exposures.

Glossary

12-month yield	A measure of the Fund's income distributions as a percentage of the Fund's net asset value (NAV). This is calculated by summing the income distributions over a rolling 12-month period, then dividing by the sum of the NAV at the end of the period and any capital gains distributed over the same period.
Annualised performance	The average amount of money (total return) earned by an investment each year over a given time period. For periods longer than one year, total returns are expressed as compounded average returns on a yearly basis.
Cumulative performance graph	This illustrates how an initial investment of R100 or N\$100 (for example) placed into the Fund would change over time, taking ongoing fees into account, with all distributions reinvested.
Income distribution	The dividend income and/or interest income that is generated by the underlying Fund investments and that is periodically declared and distributed to investors in the Fund after all annual service fees.
Information ratio	Measures the Fund's active return (Fund return in excess of the benchmark) divided by the amount of risk that the manager takes relative to the benchmark. The higher the information ratio, the higher the active return of the Fund, given the amount of risk taken and the more consistent the manager. This is calculated over a 3-year period.
Maximum drawdown	The largest drop in the Fund's cumulative total return from peak to trough over any period.
Monthly volatility (annualised)	Also known as standard deviation. This measures the amount of variation or difference in the monthly returns on an investment. The larger the annualised monthly volatility, the more the monthly returns are likely to vary from the average monthly return (i.e. the more volatile the investment).
Percentage of positive rolling 12 months	The percentage of months, since inception, that the Fund has shown a positive return over a rolling 12-month period.
Sharpe ratio	The Sharpe ratio is used to measure how well the return of an asset compensates the investor for the risk taken. The higher the Sharpe ratio the better the Fund's historical risk-adjusted performance has been. This is calculated by taking the difference between the Fund's annualised return and the risk-free (cash) rate, divided by the standard deviation of the Fund's returns. This is calculated over a 3-year period.
Sortino ratio	This is calculated by taking the difference between the Fund's annualised return and the risk-free (cash) rate, divided by the downside deviation of the Fund's returns i.e. the "bad" volatility. A high Sortino ratio indicates a low risk of large losses occurring in the Fund. This is calculated over a 3-year period.
Total Expense Ratio (TER)	This shows the charges, levies and fees relating to the management of the portfolio and is expressed as a percentage of the average net asset value of the portfolio, calculated for the year to the end of the most recent completed quarter. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TERs.
Total Investment Charges (TIC)	The percentage of the value of the Fund incurred as costs, relating to the investment of the Fund. As fund returns are reported after deducting all fees and expenses, these costs (the TER and TC) should not be deducted from the fund returns.
Transaction Costs (TC)	The percentage of the value of the Fund incurred as costs relating to the buying and selling of the Funds underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.
Unit class	M&G's Funds are offered in different unit classes to allow different types of investors (individuals and institutions) to invest in the same fund. Different investment minimums and fees apply to different unit classes. A Class: for individuals only. B & D Class: retirement funds and other large institutional investors only. X Class: the special fee class that was made available to investors that were invested in the Dividend Income Feeder Fund. T Class: for investors in tax-free unit trusts. F Class: for Discretionary Fund Managers.
