The manager may invest in participatory interests or any other form of participation in portfolios of collective investment schemes. The portfolio may invest in financial instruments. The manager may also include forward currency, interest rate and exchange rate swap transactions. Equity exposure may be as high as 40%. The manager shall reserve the right to close the portfolio to new investors. This will be done in order to manage the portfolio in accordance with its mandate.


