

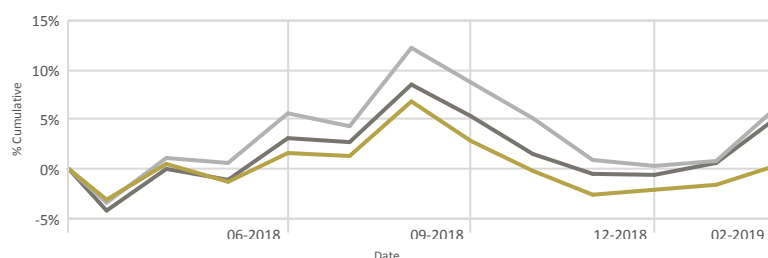
INVESTMENT OBJECTIVE

INVESTMENT UNIVERSE

The manager shall have the maximum flexibility to vary assets between the various markets, asset classes and countries to reflect the changing economic and market conditions. It may invest in global and local equity securities, interest bearing securities, property shares, property related securities, preference shares, bonds, money market instruments, non-equity securities and assets in liquid form. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instrument. The manager may also include forward currency, interest rate and exchange rate swap transactions.

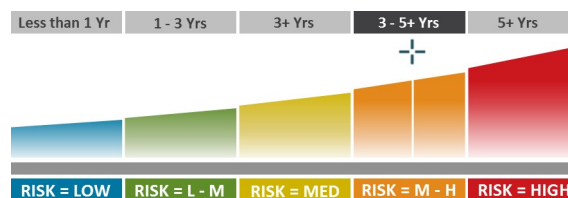

Medium - High Risk
