### **Fund Objective**

The portfolio aims to offer both income and capital growth through a well-diversified bond portfolio. This fund may invest 45% offshore.

#### **Fund Strategy**

The fund aims to offer both income and capital growth through a well-diversified bond portfolio. The fund will invest in a combination of fixed interest securities, including national government, parastatals, municipal and corporate bonds. The Manager may from time to time invest in listed and unlisted financial instruments in accordance with the provisions of the Act, and the sub-ordinate legislation thereto, as amended from time to time, in order to achieve the fund's investment objective. Apart from the above securities, the Sanlam Investment Management Bond Plus Fund may also invest in participatory interests in collective investment schemes registered in South Africa or of participatory interests in collective investment schemes or similar schemes operated in territories with a regulatory environment which is to the satisfaction of the manager and trustee of a sufficient standard to provide for investor protection at least equivalent to that in South Africa.

- \*This fund gives you active exposure to the South African bond market and should form part of a well diversified portfolio.
- \*The fund aims to achieve capital growth by investing in long term fixed interest securities.
- \*Over time, the fund should produce returns in excess of a money market fund, but at higher risk.


