Fund Objective

This is a pure equity, sector specific fund which aims to outperform the FTSE/JSE Financial Index by investing in the financial services industry. The fund may invest a maximum of 45% of assets offshore. This fund generally displays more volatility than a general equity fund.

Fund Strategy

This specialist fund focuses on maximum capital growth by investing in shares engaged in the financial services sector both locally and abroad. These companies may include banks, insurance companies and other companies engaged in the financial services industry. This fund may also invest in participatory interests of underlying unit trust portfolios.

Fund Features

If you require pure exposure to the financial sector including banks, life assurers and financial services companies - then this fund is for you. As a result of the Sanlam Investments pragmatic value investment philosophy, the fund invests in companies which are undervalued in relation to realistic growth prospects.

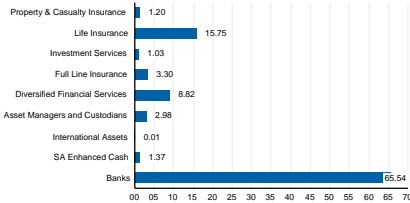

Risk Profile (Aggressive)

This is an aggressively managed, high-risk portfolio that aims to deliver capital growth over the long term (greater than 5 years). The portfolio will be diversified across all major asset classes with significant exposure to equities, and may include offshore equities. There may be some capital volatility in the short term, although higher returns may be expected from five years or beyond.
