INVESTMENT OBJECTIVE

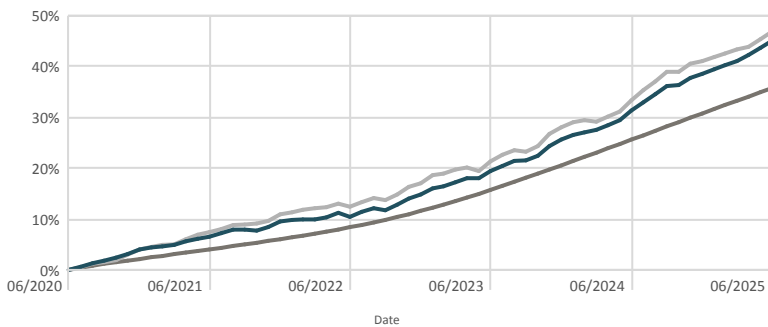
The objective of this portfolio is to maximize interest income and preserve the portfolio's capital and provide liquidity.

INVESTMENT POLICY

Investments to be included in the Fund will apart from assets in liquid form, consist of interest bearing and non-equity securities, fixed interest instruments (including but not limited to bonds, cash or fixed deposits and money market instruments), debentures and preference shares of an income nature, property securities as well as other income enhancing securities which are considered consistent with the portfolio's primary objectives. The manager may include other high yielding securities and such other local or offshore investments as legislation permits from time to time. The manager may also include unlisted forward currency, interest rate and exchange rate swap transactions.

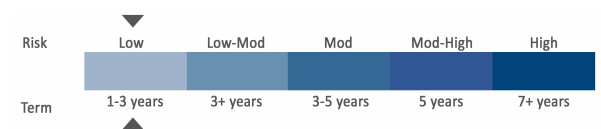

Low Risk

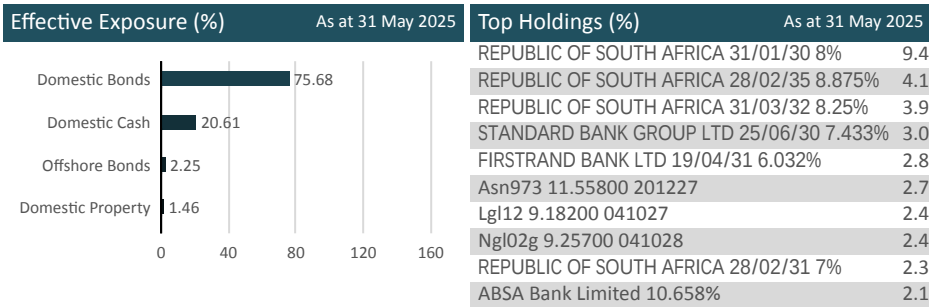
- This portfolio has no equity exposure or in some cases up to 10% equity exposure, resulting in low risk, stable investment returns.
