

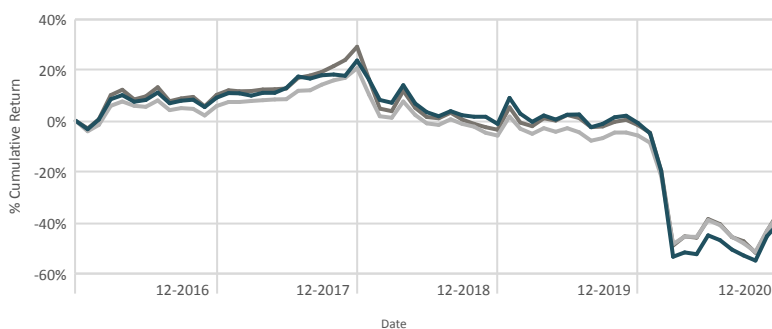
INVESTMENT OBJECTIVE

INVESTMENT POLICY

The Select BCI Property Fund will be a specialist portfolio that will consist of financially sound property securities, property related securities and participatory interests in collective investment schemes in property listed on exchanges, non-equity securities and assets in liquid form. In selecting securities for this portfolio, where possible, the manager shall seek to secure a high income yield as well as capital growth. The portfolio may invest in derivatives that will only be limited by the statutory limitations placed on the inclusion of financial instruments in portfolios. The portfolio property exposure will always exceed 50%.

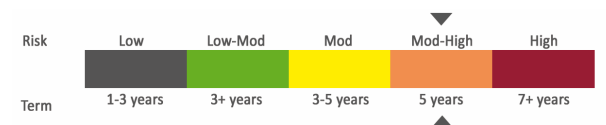
