INVESTMENT OBJECTIVE

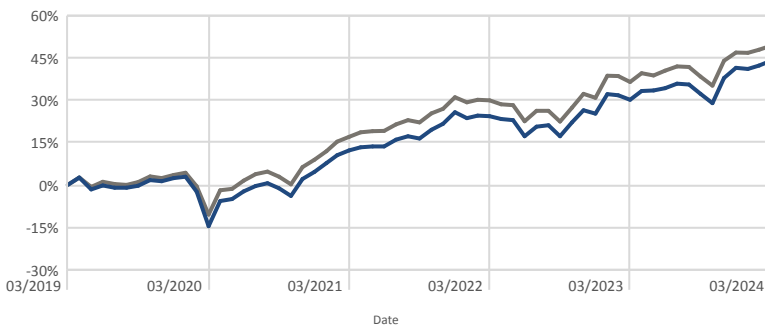
The investment objective of the Select Manager BCI Balanced Fund of Funds is to provide investors with long term capital growth.

INVESTMENT POLICY

The portfolio's equity exposure will be maximum 75% of its net asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consists of participatory interests and other forms of participation of local and global collective investment schemes, investing in equity securities, property securities, non-equity securities money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities.

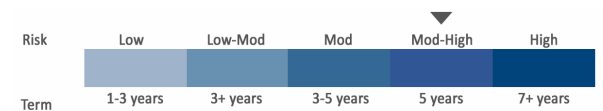

Moderate - High Risk
