INVESTMENT OBJECTIVE

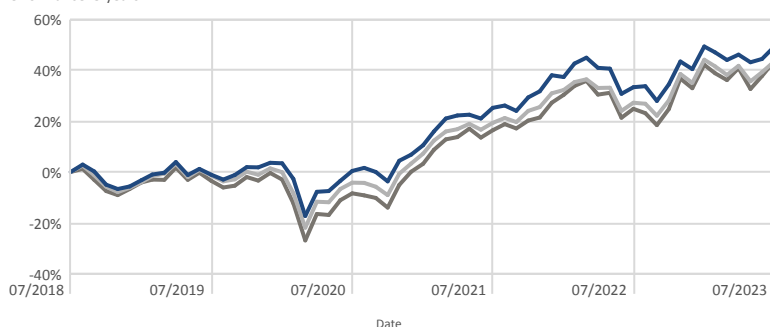
In selecting securities for this portfolio, where possible, the manager shall seek to sustain high long-term capital growth.

INVESTMENT POLICY

The Select Manager BCI Equity Fund is a general equity portfolio that may consist of financially sound equity securities, property shares and property related securities listed on exchanges, preference shares, money market instruments and assets in liquid form. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes, registered in South Africa. The portfolio's equity exposure will always exceed 80% with the balance, if any invested in assets in liquid form. The portfolio may from time to time invest in financial instruments.

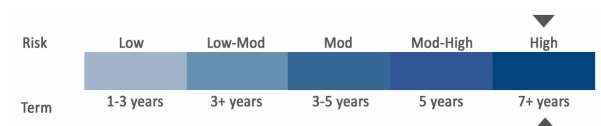
