

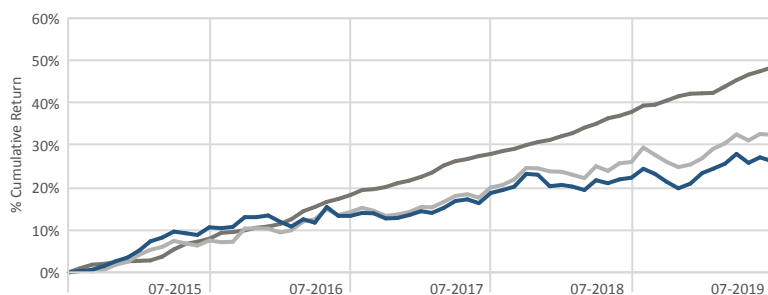
### INVESTMENT OBJECTIVE

The Sharenet BCI Conservative Fund of Funds is a cautious risk profile portfolio with the objective to provide investors with a high level of income and capital stability.

### INVESTMENT UNIVERSE

To provide a limited level of capital protection, the portfolio's equity exposure may be as high as 40% of the portfolio's net asset value. The underlying portfolios will invest in, amongst others, equity securities, property securities, non-equity securities money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities.

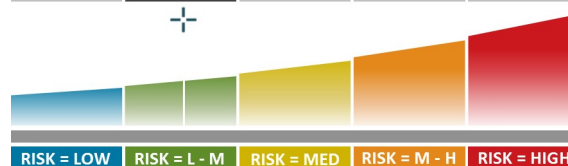
