

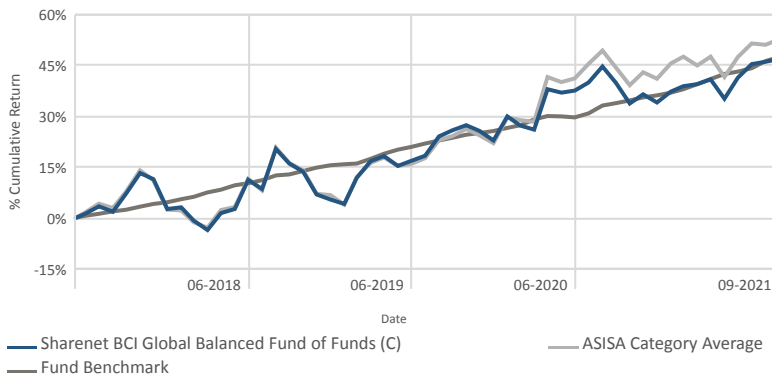
INVESTMENT OBJECTIVE

The Sharenet BCI Global Balanced Fund of Funds is a moderate to aggressive risk profile global portfolio that aims to provide investors with a high long-term total return by way of investing actively across asset classes.

INVESTMENT POLICY

The portfolio's combined direct and indirect offshore exposure will be at least 80% of its asset value whilst its maximum equity exposure will be limited to 75% of its asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes operated in territories with a regulatory environment which is to the satisfaction of the manager and trustee of a sufficient standard to provide investor protection at least equivalent to that in South Africa and which is consistent with the portfolio's primary objective. The underlying portfolios will invest in, amongst others, equity securities, property securities, non-equity securities money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities.

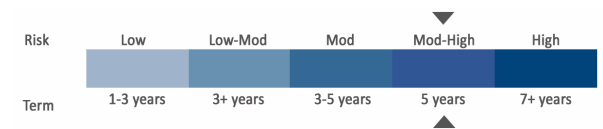

RISK PROFILE



Moderate - High Risk
