

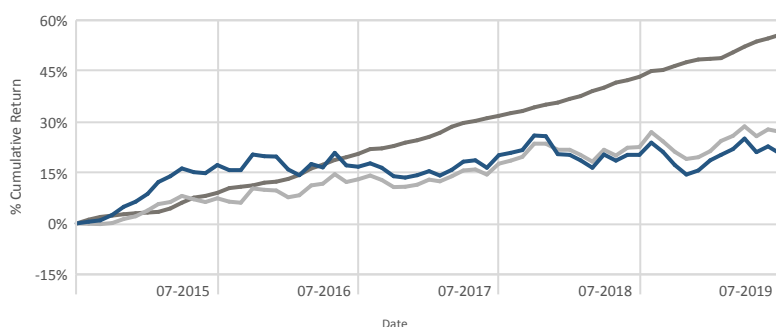
INVESTMENT OBJECTIVE

INVESTMENT UNIVERSE

The portfolio will be managed by at least two investment managers. The portfolio's equity exposure is limited to a maximum of 60% of the portfolio's net asset value. 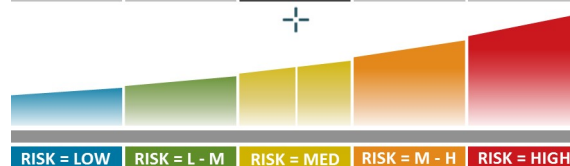
