

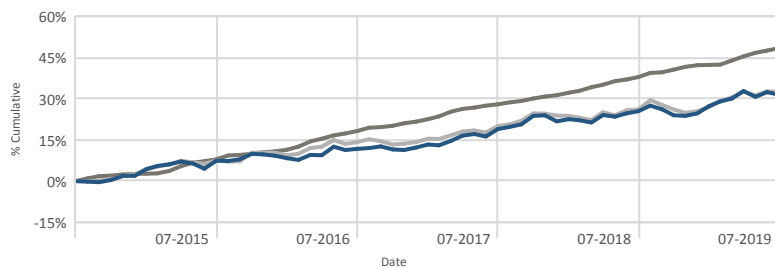
## INVESTMENT OBJECTIVE

The Sharenet BCI Stable Fund is a cautious managed portfolio with the investment objective to achieve above real inflation beating total returns by way of delivering relatively high income with a measure of capital growth over the medium to long term.

## INVESTMENT UNIVERSE

To provide a limited level of capital protection, the portfolio's equity exposure may be as high as 40% of the portfolio's net asset value. Protection strategies may be implemented to reduce risk and volatility. In order to achieve its objective, the investments normally to be included in the portfolio may comprise a combination of assets in liquid form, money market instruments, interest bearing securities, bonds, debentures, corporate debt, equity securities, property securities, preference shares, convertible equities and non-equity securities. The manager may only include the following unlisted financial instruments: forward currency, interest rate and exchange rate swap transactions.

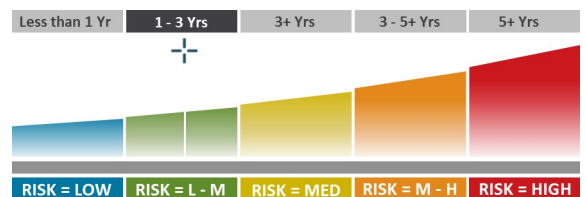
