

INVESTMENT OBJECTIVE

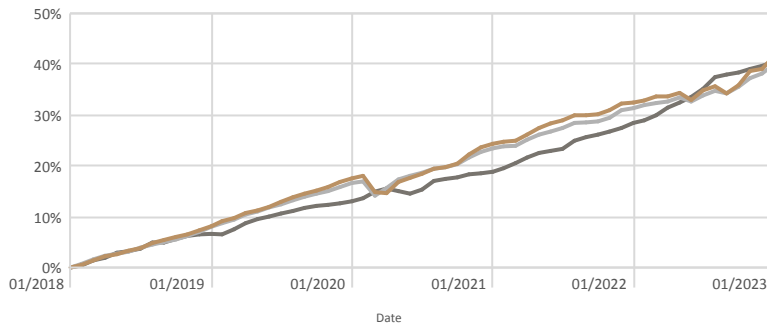
The primary investment objective of the portfolio is to provide the investor with a high level of income and stable capital growth. The recommended investment term is up to 1 year.

INVESTMENT POLICY

The Simplisiti BCI Income Plus Fund of Funds is an enhanced income fund of funds. The primary investment objective of the portfolio is to provide the investor with a high level of income and stable capital growth. It will invest in a broad range of participatory interests and other forms of participation in schemes covering a broad range of investment philosophies in order to achieve a portfolio that reflects the investment objectives of the portfolio. The portfolio will comply with prudential investment guidelines, however, to provide a limited level of capital protection, the portfolio's equity exposure may be as high as 10% of the portfolio's net asset value.

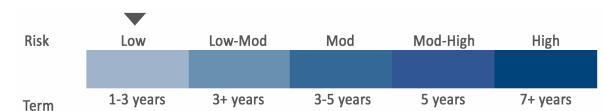

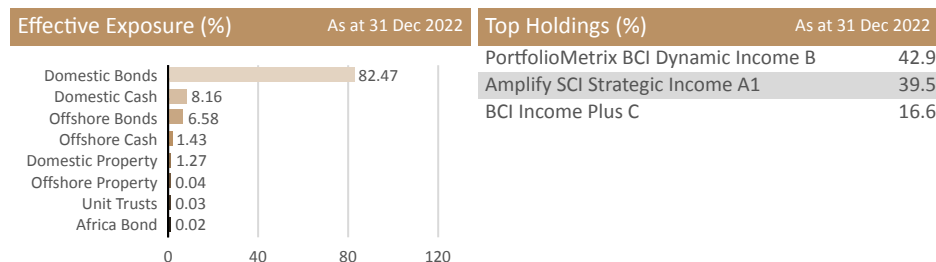
Low Risk
